### **MEMBERSHIP FEES**

The member will not be released from their obligation with regard to any payment of the membership fees as agreed to herein. The member is not entitled to any deduction or allowance for any payment made by reason of the member's absence or withdrawal from EOA Driving Range, nor by the member's failure to attend or to utilise the facilities of EOA driving range. Membership fees are strictly non-refundable.

### **DEFAULT**

Should the member fail to pay any amount due by him/her to EOA Driving Range on the due date thereof, or breach any terms or conditions of this agreement, or of EOA Driving Range Rules and Regulations; or should EOA Driving Range, acting reasonably, regard the member's general conduct as unacceptable, the EOA Driving Range shall have the right to summarily suspend or terminate such member's membership, at the sole and absolute discretion of the EOA management. Notwithstanding such suspension or cancellation, in the event of non-payment or any amount due by the member to the EOA Driving Range, the full contract price due by the member to the EOA Driving Range shall become immediately due, owing and payable.

### **FREEZING/SUSPENSION OF CONTRACT**

This contract cannot be frozen for any reason, unless written approval is obtained from the EOA Golf Management, along with proof of a doctor's note or proof of travel. This contract may be frozen for a minimum of one calendar month to a maximum of six months in a twelve-month cycle, for medical reasons or when travelling abroad. A R125 suspension levy will be due for each month of the term for which the suspension is requested.

### **CLOSURE OF CLUB AND/OR ALTERATION OF HOURS**

Should the EOA Driving Range, in its discretion, deem that maintenance work needs to be undertaken with respect to its premises, the EOA Golf Management may close its facilities for the period required for completion of such maintenance.

- The EOA Driving Range hours of operation will be displayed and the EOA golf department reserves the right to change these hours from time to time or as may be deemed necessary.
- Under no circumstances shall the member, or any third party, have any claim of whatsoever nature against the EOA Driving Range, arising out of, or consequent to this closure RIGHT OF ADMISSION RESERVED. The EOA Driving Range hereby reserves its right to enter into this agreement with any person, or to grant membership of, or access to the EOA Driving Range, at its sole and absolute discretion.

### **LIMITATION OF LIABILITIES**

I agree and acknowledge that the EOA Driving Range will not be liable for the death, injury, loss or damage suffered by me and/or the member through or contributed to by any cause whatsoever, including but not limited to any negligent act and/or omission or breach on the part of the EOA Driving Range, its directors, employees, contractors or other members.
